

## Game Time WAIVER OF LIABILITY

Game Time Sports, LLC endeavors to provide a safe environment for you, your family and guests. Game Time Sports, LLC provides exciting, healthy programs that involve exercise and physical activity. These activities have a significant amount of risk associated with them, including the potential for permanent paralysis and death. This form is to make you aware of those risks and to acknowledge your assumption of certain responsibilities for your decisions and actions.

In consideration of being permitted to voluntarily participate in activities involving exercise and physical activity, **the undersigned, for himself or herself or the above designated minor, for whom the undersigned acknowledges and represents that he or she is a parent or duly authorized guardian, hereby knowingly and feely assumes all risks, both known and unknown, even if arising from the negligence of Game Time Sports, LLC, its managers, members, employees, independent contractors, sublessees and each of them (hereinafter collectively referred to as "Game Time") and releases, waives, and forever discharges Game Time from all liability to the Participant, his or her spouse, legal representatives, heirs, assigns, children, or anyone claiming by or through Participant, for any loss, damage, liability, claim, demand, action, cause of action, cost, or damages resulting therefrom, on account of injury to Participant's person or property that occurs while Participant is on the premises of Game Time Sports, LLC or while participating in the aforementioned activities, including without limitation injury resulting in the death of the Participant, whether caused by simple negligence of Game Time, or any of them, or otherwise but excepting claims arising from and to the extent of the gross negligence or willful or wanton misconduct of Game Time.**

The undersigned, for Participant, agrees to indemnify and hold harmless Game Time, and each of them, against any loss, damage, liability, claim, demand, action, cause of action, cost or damage resulting therefrom that they may incur due to the presence of Participant in or upon the premises of Game Time Sports, LLC or aboard any equipment of Game Time whether caused by the negligence of Game Time, or any of them, or otherwise but excepting claims arising from and to the extent of the gross negligence or willful or wanton misconduct of Game Time.

Being duly aware of the risks and hazards associated with the aforementioned activities, the undersigned, for Participant, hereby voluntarily assumes full responsibility for the risk of bodily injury, death, or property damage due to the negligence of Game Time, or any of them, or otherwise that occurs while Participant is in or upon the premises of Game Time Sports, LLC, using any equipment of Game Time, or participating in the aforementioned activities.

The undersigned, for Participant, willingly agrees to comply with the terms and conditions for participation. If the undersigned observes any unusual significant hazard during his or her presence or participation, the undersigned will remove Participant from participation and bring such to the attention of the nearest representative of Game Time immediately.

In the event that a medical clearance must be obtained prior to the Participant's participation, I agree to consult Participant's physician and obtain written permission therefrom prior to commencement of any activity on the premises of Game Time Sports, LLC. The undersigned, for Participant, agrees to assume the natural risks associated with exercise and physical activity.

The undersigned, for Participant, authorizes the use and reproduction of any and all photographs or video footage for Game Time marketing and advertising purposes without compensation, and I understand that it is the personal responsibility of Participant to avoid being photographed if he or she so desires.

The undersigned expressly agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Georgia, and does not purport to relieve Game Time from gross negligence or willful or wanton misconduct. If any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
